Decides as follows

Article 1: The Ministry of the Interior and Municipalities has taken notice of the establishment of the association called:

ASSOCIATION OF INDUSTRIAL SMALL AND MEDIUM-SIZED ENTERPRISES

Headquarters: Fanar - real estate 934- sections 4, 5 and 8 - Naimeh Building - Property of Jean Naimeh - Metn District.

Object: The association aims to:

- 1- Consolidate the bond of friendship and cooperation, encourage and support the development of Lebanese small and medium-sized industrial associations on the one hand and Italian and European small and medium-sized industrial associations on the other hand.
- 2- Provide support, collaboration and assistance through Italian donor associations, the European Union, moral entities, Non-Governmental Organizations to contribute to the growth of industrial associations, small and medium-sized enterprises

in the artisanal, agricultural, environmental, cinema, television, petrol and miscellaneous activities at all levels.

3- Prepare studies, hold conferences, seminars and cultural debates and organize scientific exhibitions.

4- Prepare surveys and seminars, create libraries, publish cultural publications, show films and documentaries.

5- Prepare special sessions in technical, economic and social sciences.

6- Create committees or groups specialized in studies and research.

7- Contribute in similar objects and participate in social and humanitarian activities.

The above points are applied in accordance with the laws and regulations in force and after the approval of the competent authorities.
